**OLD BUSINESS:**

Trustee Patterson made a motion to approve Ordinance 2022-02, An Ordinance Allowing Chicken Coops Within Corporate Limits of the Village of Loami, Amending Section Animal Control. Trustee Grider seconded the motion. Roll call – Grider – Aye, Holloway – Aye, Mann – Aye, Patterson – Aye, Pippin - Aye, Nay – 0.

Trustee Patterson asked the status of the new roof for the food pantry. Clerk Grider stated that the food pantry received an updated bid to include a standard standing seam metal roof and the bid was in significantly higher than a shingled roof. The food pantry will be moving forward with a shingle roof.

**NEW BUSINESS:**

Trustee Patterson stated the senior citizen dinner went really well and there were around 14 that attended. Trustee Mann asked since there was a low attendance if the village would like to continue to have the dinner. Trustee Pippin stated that we should do it one more year and see if the attendance increases. Trustee Patterson inquired about making a parking lot on the lot north of the community center. Trustee Patterson stated that the gutters need to be cleaned out at the community center.

### **DEPARTMENT REPORTS:**

**PARKS** – Trustee Patterson stated the park needs electrical work done and he will be in contact with Ruby Electric in March 2023 to start work on the electrical.

**STREETS DEPARTMENT** – Trustee Pippin stated he will talk with William Roesch, Water Superintendent in regards to next years sidewalk project.

**POLICE DEPARTMENT** – Chief Workman stated the police department was busy for the month of July. Chief Workman submitted the Police Report to the board, which is on file at the Clerk's office.
